I.V. Stands are used for the suspension of I.V. and other solutions administered by medical/paramedical /hospital personnel





#### **DEFINITIONS**

## Operator

Operator is the person appointed by the owner (i.e. clinic, hospital management, etc.) who will be responsible for the safe operation of these Wardcare Accessories and Peripherals.

# User

User is a person who is capable of assessing clinical condition of patient e.g. specialist medical personnel, doctors, nursing staff, attendants etc. On the basis of their training experience or through the instructions, they are entitled to use these Wardcare Accessories and Peripherals on their own responsibility or to carry out work on it and are able to recognize and control possible risks to the patient as well as the Wardcare Accessories and Peripherals.

## Patient

The patient is a person who is ill, infirm, disabled or in need of medical assistance,

#### **INSTALLATION AND OPERATION**

- 1. Unpack all the components carefully.
- 2. If the packing is drenched by rain, water or other liquids, inform this matter to the operator.
- 3. Each Product is supplied with the following components as per packing list:

Curtain Cloth -1 Set
Base frame with Castors -2 nos.
Hardware -1 packet

MS Tubular frame with Castors -1 pair
Transverse tubes -4 nos.
PU Foam Mattress -1 no.
Crib -1 no.
Hardware -1 packet






Notify if any damage has occurred during transportation either to the authorized agent or directly to Midmark India Pvt. Ltd.



Installation of the Wardcare accessories and peripherals should be done only by Midmark trained technicians (wherever required).



- 1. Remove the bolt from the base frame and fit it to central frame with side (male) and central frame with side (female). (Refer Image Above)
- 2. Spring small and large spring is already fitted with the product. Remove the springs from its hooks to insert the Curtain Cloth (as per individual frame sizes. Ensure proper inserting of hook Eye with spring holding hook.(Refer Image Above)

- 1. Place both the Tubular frames on the ground
- 2. Fix the 4 nos. of Transverse tubes to the Tubular frames as shown in the picture with the help of hardwares provided.
- 3. Hang the Crib in the hooks provided on the frame
- 4. Place the Mattress inside the Crib.

Rest all products (1043A / 1043B / 1044 / 1044A / 1021 / 1022 / 1023 / 1601 / 1601A / 1602 / 1602A / 1612 / 1812 / 1811 / 1603 / 1604 / 1069 ) are factory fitted and come in ready to use condition.



- 1. Do not use the stools for standing or loading
- 2. Do not use the I.V stands for purposes other than the intended use as it may cause damage to the patient / equipment

#### MAINTENANCE & CLEANING

#### Maintenance

Each time before putting the Wardcare accessories and peripherals into service the user must check for -

- Lubrication of all the mechanical joints / pins / moving parts / tightening of the bolts are done properly, to avoid unnecessary play, sound and wear & tear of the Wardcare accessories and peripherals.
- Visual inspection for any mechanical damage (e.g. loose /missing rivets, screws, etc.)
- If any damage or malfunction is observed, immediately report this matter to the operator.
- If the Wardcare accessories and peripherals is not in use, it should be stored in a dry and rodent free indoor environment on a flat surface with gradient not more than 5 degrees.
- If the Wardcare accessories and peripherals is not in use for long term, it is necessary to conduct a test to check for functioning and any mechanical damage that may have been caused.
- Depending on the usage, certain moving parts may require replacement due to wear & tear. We recommend timely replacement with original spares for safety and trouble free operation.



Any kind of fire source should be prohibited near the mattress / cloth material to avoid any fire hazard as these materials do not have flame retardant properties.

#### Cleaning & Disinfecting

- The Wardcare accessories and peripherals are not suitable for machine wash or steam cleaning.
- Do not use water jet for cleaning.
- The Wardcare accessories and peripherals cannot tolerate the influence of strong solvent, basic or alkaline liquids & caustic agents.
- The cleaning agents must not contain any substances which bring about any change in the structure or adhesive property of the plastic.
- The Wardcare accessories and peripherals should be properly cleaned and disinfected at regular intervals to
  avoid infection and stains. Immobilize the Wardcare accessories and peripherals & remove all the detachable
  accessories and components before cleaning.
- We recommend use of approved disinfectant and cleaning agents to clean the Wardcare accessories and peripherals. Take extra care to clean areas that may trap dust or dirt. All detachable accessories and its component can be cleaned separately.





Do not expose the Wardcare accessories and peripherals to excessive moisture as corrosion may cause personal injury or equipment damage.

# Disposal:



Product and its defective parts especially elements made of plastic, steel, rubber, curtain cloth material should be disposed off in accordance with the statutory rules and regulations prevailing for such disposal. The user is advised to contact Midmark India Pvt. Ltd. for further assistance.
